THIS IS EVEN MORE THE CASE FOR YOUNG BLACK, INDIGENOUS AND PEOPLE OF COLOR (BIPOC) AND THOSE WHO IDENTIFY AS LGBTQ, WHO FACE UNIQUE CHALLENGES ASSOCIATED WITH RACISM AND PREJUDICE. IN FY24 AT CHPA, AT LEAST 87% OF YOUTH WHO ACCESS RESIDENTIAL SERVICES SELF-IDENTIFY AS BIPOC, AND 23% IDENTIFY AS LGBTQ.
